After you log in you will be taken automatically to YOUR PROFILE.


You can always access your courses and certificates from YOUR PROFILE (this will appear when you are logged in).

Bilingual Website

If you are unable to see your courses you can toggle between languages. If a course was purchased from the French side of the website it will be located under Your Profile under the French (Français) language tab.

Starting your course

1. From YOUR PROFILE you can click on the course you wish to begin. You will be taken to the Course Page.




Begin your course by clicking on the 1st Module. You will be taken to the Module 1 Page. Some courses will have text to read though and some will have videos. Complete the required task for the module and you will be invited to continue on to the next step.

If your lesson is video based your quiz will appear automatically upon the completion of the video.

If your course is text based you will need to click the Mark Complete button at the end of the content.

This might be a quiz or progression to the next module in the course.



Quizzes

Quizzes are a component of each Course. They may come at the end of a module or at the end of your course.

Most quizzes will require a certain score in order to move onto the next step of your course. If you do not reach this score you will be able to retake your quiz but there will be a limit to the number of retakes you can do. Some quizzes will also have a time limit to them. Make sure you are ready to take your quiz prior to clicking the Start Quiz button.

1. Once you have complete the Module the next step of your course will appear. In this example it is a Quiz.



2. Click on the Quiz section. Your Quiz page will appear. Once you are ready to begin you quiz you can click the Start Quiz button.



As you move through the Quiz you questions will appear.
